



## Summer Credit Advancement 2020

- JVA will once again be offering two four-week sessions in the summer of 2020 for students seeking credit advancement. This is NOT credit recovery.
- Courses are only available to current Jeffco high school students. Students must be classified as a sophomore or higher at the time of application.
- Students make take only ONE course for .5 credit each four-week term.
- Each 4-week course will yield a semester .5 credit.
- Students will be required to work 20+ hours per week to complete the semester course in four weeks.
- Courses are entirely online and taught by licensed Jeffco teachers.
- The cost is the same as the summer school fee per course per session. This fee covers the cost of the teacher. This fee has not yet been determined at the district level for summer of 2020. The cost in 2019 was \$165 per semester course.
- Students do NOT have to take English 12 A in order to take English 12 B.
- Here are the course offerings this year. None of these courses are honors level or for college credit:
  - Regular English 12 A – Session 1
  - Regular English 12 B – Session 2
  - US Government – Session 1
  - Economics – Session 1 and 2
  - World Geography – Session 2
  - Lifetime Fitness – Session 1 and 2

The home school counselor must complete a Counselor Verification form for each student. If this form is completed by the student or parent, it will not be accepted.

## Policies and Procedures

- Student must meet the grade-level requirement—10<sup>th</sup> grade at the time of application.
- Student must have a completed Counselor Verification on file.
- It is the student's responsibility to let his or her home high school counselor know the intention to take a JVA summer credit advancement course and to let the counselor know that he or she must complete the verification.
- All fees must be paid in full for both sessions no later than May 29<sup>th</sup>.
- There are no refunds once each session starts.
- Students may drop the class during the first week of each session only. Drop notification must be received by 3 pm on the first Friday of each session. If the class is dropped, no grade for the course will be added to the official transcript and there will be no refund issued.
- After the drop date deadline, the student will receive the grade earned and it will be added to the official transcript.
- There are NO extensions to these sessions. Each session is four weeks and will close on the last Friday of the session at 11:59 pm.
- Students are expected to complete all work each week for the four-week session. This is not a work-at-your-own-pace structure.
- Teachers are available virtually during daily office hours to support students. Teacher office hours will be Monday through Friday but not on weekends. Students will have 24/7 access to the classes but not 24/7 access to teachers.
- All courses use the JVA traditional Schoology courses and are NCAA approved.
- In early August, grades will roll to transcripts.
- Courses must meet minimum enrollment numbers or they will be cancelled.
